

## Member Appreciation Giveaway Official Rules Revised Date: 2/8/24

**Promotional Period:** The giveaway promotion period begins Monday, April 1, 2024, and ends on Friday, December 6, 2024. The promotion period spans eight (8) months. The promotion is subject to change without prior notice.

Eligibility: No purchase or payment is required to win a prize or to participate in the promotion. Only members of Wailuku Federal Credit Union in good standing are eligible to participate. Member must be an active member (non-dormant), current on all loans, have a minimum of \$50.00 (par value) in their share account, opted in to receive all credit union communications, and have up to date contact information. Account must be opened at least thirty (30) days prior to the date of prize drawing. Participants must be age eighteen (18) or older. Members can only win once. Other restrictions may apply.

**Entry:** All members that meet eligibility requirements stated above will be automatically entered into the monthly drawing.

**Drawing Period**: Drawings will be conducted monthly at 133 Ma'a St., Kahului, HI. The first drawing will be held on or about Monday, April 1, 2024, for all qualified entries, followed by monthly drawings for qualified entries. The final drawing will be held on or about Monday, December 2, 2024.

**Prizes:** Odds of winning are based on the number of eligible entries. Prizes for subsequent drawings are subject to change.

Conditions: The winner will be notified via phone or, if necessary, via email.
