| WHAT? | <p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> * Social Security Number * Account Balances * Transaction and loss history * Overdraft History * Account Transactions * Checking Account Information <p>When you close your Wailuku Federal Credit Union account, we continue to share information about you as described in this notice.</p> | | |
| HOW? | Credit Union’s need to share member’s personal information to run their everyday business and to process transactions, maintain member accounts, and report to credit bureaus. | WHAT WE DO | |
| How does Wailuku Federal Credit Union protect my personal information? | To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. |
| How does Wailuku Federal Credit Union collect my personal information? | <p>We collect your personal information, for example, when you:</p> <ul style="list-style-type: none"> • Open an account or apply for a loan • Provide account or mortgage information • Use your debit card • Show your driver's license <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies</p> |
| Why can't I limit all sharing? | <p>Federal law gives you the right to limit only:</p> <ul style="list-style-type: none"> • Sharing for affiliates' everyday business purposes- information about your creditworthiness • Affiliates from using your information to market to you • Sharing for non-affiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing</p> |
| What happens when I limit sharing for an account I hold jointly with someone else? | Your choices will apply to everyone on your account |

| Affiliates | <p>Companies related by common ownership or control. They can be financial and non-financial companies.</p> <ul style="list-style-type: none"> • <i>Wailuku Federal Credit Union has no affiliates</i> |
| Non-affiliates | <p>Companies not related by common ownership or control. They can be financial and non-financial companies</p> <ul style="list-style-type: none"> • <i>Nonaffiliates we share with can include insurance companies, government agencies, plastic card processors (debit/ATM), financial statement publishers or printers, mailhouse, mortgage service companies, consumer reporting agencies, data processors, check/share draft printers, and direct marketing companies.</i> |
| Joint Marketing | <p>A formal agreement between non-affiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> • <i>Our joint marketing partners include insurance companies and financial service providers.</i> |
